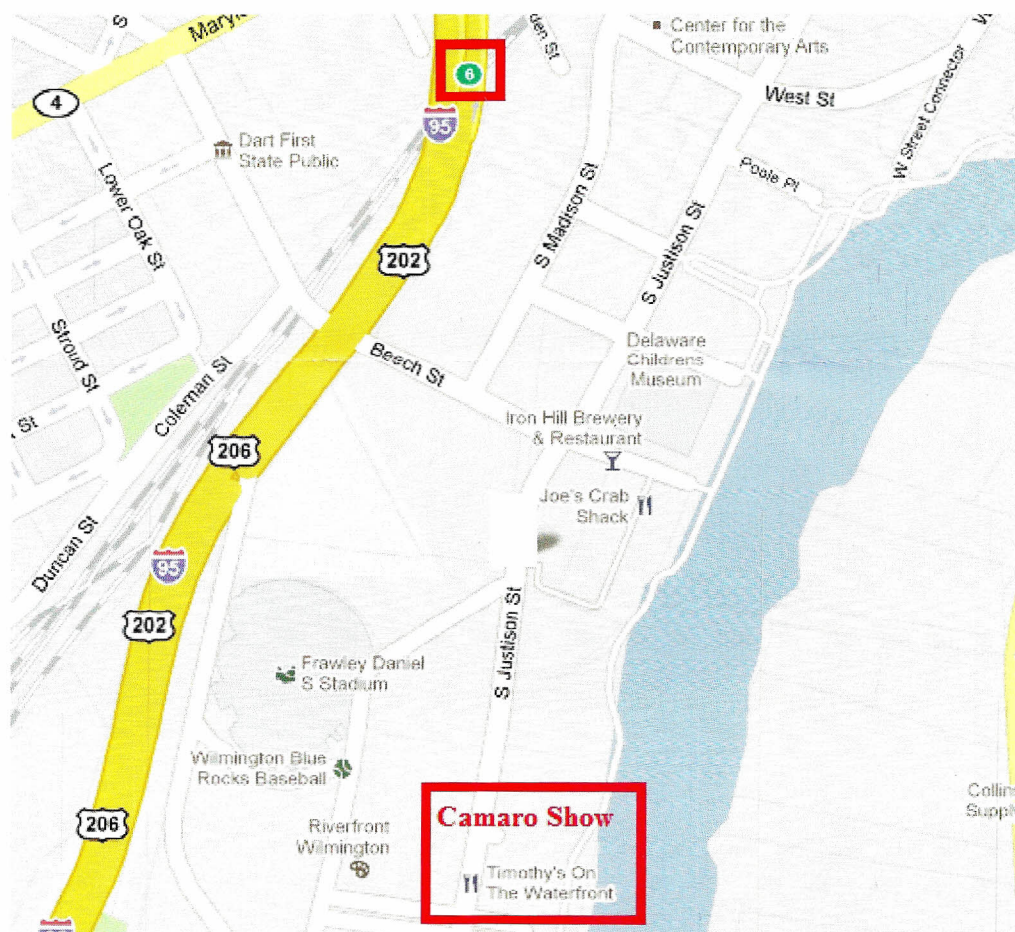


The Delaware Valley Camaro Club uses a judging system that we feel provides a more competitive environment for all of our participants where "Top-25" awards are given to the most worthy Camaros and/or Firebirds on the show lot regardless of classification or year. This makes for a more competitive show and ensures that all Camaros & Firebirds are given an equal opportunity. Therefore, participants do not have to select a class when registering. \*DVCC club member cars are not eligible for judging\*\*
